For your application to be reviewed, the following documents must be submitted to the Chicana/o and Central American Studies Department (CCAS). - 1. A completed and signed application
- 2. Current Curriculum Vitae
- 3. A current copy of your UCLA academic transcripts. **NOTE:** Unofficial transcripts issued from Murphy Hall or electronic printouts from a personal computer will be accepted.

TA applications are reviewed, and appointments are assigned by the CCAS TA selection committee. You will be notified once all selections have been made. Questions or concerns should be addressed to Ellie Hernández (scheduling@chavez.ucla.edu) and Janeth Ruvalcaba (janeth@chavez.ucla.edu).

All first-time Teaching Assistants are required to enroll in CCAS 495 or equivalent, a pedagogy course that includes the Professional Standards and Ethics Training (PSET). All applicants hired above 50% must complete the <u>over 50% work exception</u> in advance of the hiring start date. If you hold a work position at UCLA besides a TA, please indicate this information on your application. Important Notice:

Pursuant to Article 11 - Fee Remission, eligible graduate student employees appointed at 25% or greater are entitled to 100% remission of tuition and eligible fees charged. The fees included in the fee remission are the: (1) Student Services Fee, (2) premium for the Student Health Insurance Program (SHIP), and (3) 100% partial fee remission toward campus fees as set forth in the collective bargaining agreement. UC will cover Nonresident Supplemental Tuition for up to three (3) years for eligible ASEs employed at 25% or greater who have advanced to doctoral candidacy in their degree program.
